

AEA Federal Credit Union Scholarship

2009-2010

The AEA Federal Credit Union Scholarship provides financial assistance to worthy students from Yuma or LaPaz counties attending Northern Arizona University at the Yuma campus. Scholarship funds are generated from an endowment established by AEA Federal Credit Union in cooperation with the NAU Alumni Association Yuma Chapter. The scholarship is administered by Northern Arizona University in Yuma, the NAU Alumni Association Yuma Chapter, and the NAU Foundation.

Scholarship Requirements and Guidelines

Applicants/Recipients must:

- be residents of Yuma or LaPaz counties
- be planning to enroll as full-time students at NAU-Yuma for 2009-2010
- have completed at least 36 credit hours at an accredited college or university
- have a 3.0 cumulative GPA through the fall semester of the current academic year
- have their scholarship application submitted by March 20, 2009.

The scholarship:

- is a one-year academic scholarship
- requires that the recipient establish and maintain at least a 3.0 cumulative GPA in order to be considered for renewal of the scholarship for the spring semester of the school year
- requires that the recipient complete at least 12 hours per semester with NAU
- is not automatically renewed (the recipient must reapply each academic year).

Instructions for Application

1. Type the attached APPLICATION, sign and date. Incomplete or handwritten applications will NOT be considered.
2. Write a PERSONAL STATEMENT (one-page typed) which includes the following:
 - Community Service
 - Educational and career goals
 - Personal accomplishments, extracurricular activities and community activities
 - An explanation of why you want or need this scholarship.
3. Obtain and attach TWO LETTERS OF REFERENCE.
4. Obtain and attach COLLEGE TRANSCRIPTS. Continuing college students, attach a copy of your transcript for each college previously attended or currently attending that includes the Fall 2008 grades. Unofficial copies are acceptable.
